John Gulliver, Pierce Atwood LLP

William Harwood, Verrill

William Harwood has devoted most of his 35-year career to representing public utilities before state and federal regulatory agencies. He has represented electric, gas, water and telecommunications companies in more than 50 major cases before the Maine Public Utilities Commission and Federal Energy Regulatory Commission, including rate cases, prudence investigations, management audits, merger approvals, requests for Certificates of Public Convenience and Necessity, and rulemaking proceedings. Mr. Harwood counsels utilities on proactive strategies to both anticipate regulatory developments and efficiently manage the regulatory process. Mr. Harwood has been extensively involved in traditional rate setting issues, including CWIP in rate base, attrition, accounting orders and cost of capital. He has negotiated long-term alternative rate plans which include automatic inflation adjustments, service quality penalties, and recovery of mandated or exogenous costs. He has also negotiated numerous long-term special rate agreements between utilities and specific industrial consumers. Mr. Harwood was actively involved in the restructuring of the Maine electric utility industry, including representing utilities in the sale of their generating assets, recovery of stranded costs and providing standard offer (default) service. More recently, he has represented developers of new transmission lines in securing Certificates of Public Convenience and Necessity and wind developers in negotiating Interconnection Agreements and securing adequate transmission capacity for delivery of the output. Mr. Harwood earned a B.A. from Harvard University and a J.D., *cum laude*, from Fordham University.

Philip Bartlett II, Maine Public Utilities Commission Chair

Philip L. Bartlett II, J.D., was appointed to the Maine Public Utilities Commission in June 2019 by Governor Janet Mills. Prior to his appointment, he practiced law with Scaccia, Bartlett & Chabot. He also served in the Maine Senate from 2004 to 2012 and was elected by his peers to serve as Senate Majority Leader from 2008 to 2010. Bartlett chaired the Energy, Utilities and Technology Committee as well as the Joint Select Committee on Maine's Energy Future and he served on the Government Oversight Committee, Natural Resources Committee and Labor Committee. He taught micro and macroeconomics at the collegiate level. Chairman Bartlett holds a juris doctorate degree from Harvard Law School. Dr. David Dvorak, P.E., New England Combined Heat and Power (CHP) Technical Assistance Partnership Director and Professor of Mechanical Engineering Technology (University of Maine)

Dr. David Dvorak, P.E. is Professor of Mechanical Engineering Technology at the University of Maine, and Director of the New England Combined Heat and Power Technical Assistance Partnership. His interest and involvement in CHP systems began in 1984 when he worked as an engineer at GE Aircraft Engines in Cincinnati OH on industrial applications of gas turbine engines. Arriving at UMaine in 1988, he was Assistant Director of the UMaine Industrial Assessment Center from 1993 to 1998. From 2000 to 2007 he served as Director of the UMaine School of Engineering Technology. From 2008-2011 he served as Coordinator of the Fuel Cell Systems and Hydrogen Specialization at RES, the School for Renewable Energy Sciences in Akureyri, Iceland. A Fulbright Scholar, Dr. Dvorak has worked with renewable energy and energy conservation projects in Europe and the USA. Dr. Dvorak is a Licensed Professional Engineer, and an active member of ASHRAE.
